BRTC Named a "2015 Great College to Work For"

Black River Technical College is one of the best colleges in the nation to work for, according to a new survey by <u>The Chronicle of Higher Education</u>, the nation's best source of news about colleges and universities.

The results, released in <u>The Chronicle's</u> eighth annual report on the Academic Workplace, are based on a survey of 281 colleges and universities.

In all, only 86 of the 281 institutions achieved "Great College to Work For" recognition for specific best practices and policies. Results are reported for small, medium, and large institutions with Black River Technical College included among the universities and colleges with 2,999 students or fewer.

Black River Technical College won honors in following 3 categories: Work-Life Balance, Supervisor/
Department Chair Relationship, and Confidence in Senior Leadership.

Even more impressive, BRTC was the only 2-year college in Arkansas to receive the honor and, with John Brown University, was 1 of 2 Arkansas institutions to achieve the honor.

"This is a very satisfying affirmation of Black River Technical College, but our real goal is not recognition – it's being a community that values the needs and contributions of every individual. In that sense everyone at BRTC helps to make this a great place to work," said Dr. Eric Turner, BRTC President.



"The institutions that the Great Colleges program recognizes provide innovative educational experiences – while also offering their employees outstanding workplace experiences – and we are eager to help readers learn more about them," said Liz McMillen, <u>The Chronicle's editor</u>.

The survey results are based on a two-part assessment process: an institutional audit that captured demographics and workplace policies from each institution, and a survey administered to faculty, administrators, and professional support staff. The primary factor in deciding whether an institution received recognition was the employee feedback.

The Chronicle worked with ModernThink LLC to administer the survey and analyze the results. Great Colleges to Work For is one of the largest and most respected work-place-recognition programs in the country.

Groups Invited to Schedule "Opening Hearts and Minds" Presentations

The Task Force for "Cultural Connections: Opening Hearts and Minds in Rural Northeast Arkansas" will offer a series of presentations for civic, governmental, social, and church groups across Randolph, Clay, and Lawrence counties this fall. Several have been tentatively scheduled, beginning in September.

These community-wide presentations are designed to provide factual information that responds to such questions as "What is the net cost and the economic impact of immigrants?" "How do immigrants contribute to

Arkansas's workforce?" The presentations will also focus on such topics as citizenship and language challenges and the impact of the state's immigrants on education, housing, and health care.

The presentations were discussed at a Task Force meeting held July 21 on the BRTC campus. The Task Force includes a group of approximately 25 local community leaders who are committed to a community that is open and welcoming to the anticipated non-native workers who may come to this region as a result of new area jobs.

A highlight of last week's meeting was a presentation "What's In A Word?" by BRTC President Dr. Eric Turner who, using the book of James as text, discussed the human tendency to use words in harmful and negative ways. Turner also expressed his early and ongoing support of the efforts of the "Opening Hearts and Minds" project. He emphasized the responsibility and the opportunity for the college to be a leading positive force in this aspect of community growth.

The Task Force is a sub-committee of the Northeast Arkansas Intermodal Facilities Authority. Its activities are supported by BRTC and are funded in part by the BRTC Foundation, the Arkansas Humanities Council, and the National Endowment for the Humanities. Its purpose is to encourage and support the community's efforts to be an open, welcoming environment for its citizens.

Presentations will be based in part on a series of reports commissioned by the Winthrop Rockefeller Foundation, titled <u>A Profile of Immigrants in Arkansas.</u> "None of us are experts," noted Ziegler. "We don't pretend to be. But we

are trying to learn as much as we can about the changes that are coming, and that includes gaining a better understanding about the newcomers—the immigrants—who may come to our region as a part of our workforce."

Task Force members also received their copies of a book, <u>Enrique's Journey</u>, which will be the topic of readings and discussions in the spring. The "Opening Hearts and Minds" project will culminate with a visit and two public presentations by the book's Pulitzer Prize-winning author, Sonia Naz-

ario, April 7, 2016.

The Task Force is also accepting the names of prospective community reading groups from junior high age and older with plans to hold "community reads" sessions prior to the author's visit. Groups can choose to read all or part of the regular version of the non-fiction book, a "Young Adult" version, or a Spanish language version. These reading sessions will also be facilitated by members of the Task Force and its Team Leaders.


